Pursuant to the share consolidation timetable issued by China Health Technology Group Holding Company Limited ("China Health Technology"), the share consolidation of 10 existing shares of HK\$0.01 each in China Health Technology into 1 consolidated share of HK\$0.1 each will become effective on 8 July 2025. Shareholders, investors and market participants should read the China Health Technology's circulars and regulatory announcements in full including the terms and conditions of China Health Technology's share consolidation in dealing with China Health Technology's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of China Health Technology's OTP-C temporary stock page (stock code 2901) on 8 July 2025. Calculation of the Adjusted Previous Closing Price will be based on China Health Technology's closing price on 7 July 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
