Pursuant to the share consolidation timetable issued by Grand Talents Group Holdings Limited ("Grand Talents Group"), the share consolidation of 10 existing shares of HK\$0.10 each in Grand Talents Group into 1 consolidated share of HK\$1.00 each will become effective on 25 July 2025. Shareholders, investors and market participants should read the Grand Talents Group's circulars and regulatory announcements in full including the terms and conditions of Grand Talents Group's share consolidation in dealing with Grand Talents Group's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Grand Talents Group's OTP-C temporary stock page (stock code 8565) on 25 July 2025. Calculation of the Adjusted Previous Closing Price will be based on Grand Talents Group's closing price on 24 July 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
