Pursuant to the share consolidation timetable issued by Macau Legend Development Limited ("Macau Legend"), the share consolidation of 10 existing shares of HK\$0.1 each in Macau Legend into 1 consolidated share of HK\$1.0 each will become effective on 1 August 2025. Shareholders, investors and market participants should read the Macau Legend's circulars and regulatory announcements in full including the terms and conditions of Macau Legend's share consolidation in dealing with Macau Legend's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Macau Legend's OTP-C temporary stock page (stock code 2913) on 1 August 2025. Calculation of the Adjusted Previous Closing Price will be based on Macau Legend's closing price on 31 July 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

## Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

#### where:

R = Ratio of Share Consolidation, i.e. 10/1
