Pursuant to the share subdivision timetable issued by Hong Kong ZCloud Technology Construction Limited ("ZCloud Technology"), the share subdivision of 1 existing share of HK\$0.01 each in ZCloud Technology into 8 subdivided shares of HK\$0.00125 each will become effective on 19 August 2025. Shareholders, investors and market participants should read the ZCloud Technology's circulars and regulatory announcements in full including the terms and conditions of ZCloud Technology's share subdivision in dealing with ZCloud Technology's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share subdivision and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of ZCloud Technology's OTP-C temporary stock page (stock code 2926) on 19 August 2025. Calculation of the Adjusted Previous Closing Price will be based on ZCloud Technology's closing price on 18 August 2025 (i.e. the day immediately before the share subdivision becoming effective) and by using the following standard adjustment formula for share subdivision generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Subdivision becoming effective x R

where:

R = Ratio of Share Subdivision, i.e. 1/8
