Pursuant to the share consolidation timetable issued by Jiading International Group Holdings Limited ("Jiading International"), the share consolidation of 20 existing shares of HK\$0.0001 each in Jiading International into 1 consolidated share of HK\$0.002 each will become effective on 23 September 2025. Shareholders, investors and market participants should read the Jiading International's circulars and regulatory announcements in full including the terms and conditions of Jiading International's share consolidation in dealing with Jiading International's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Jiading International's OTP-C temporary stock page (stock code 8570) on 23 September 2025. Calculation of the Adjusted Previous Closing Price will be based on Jiading International's closing price on 22 September 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 20/1
