Pursuant to the share consolidation timetable issued by XinXiang Era Group Company Limited ("XinXiang Era"), the share consolidation of 4 existing shares of HK\$0.02 each in XinXiang Era into 1 consolidated share of HK\$0.08 each will become effective on 20 October 2025. Shareholders, investors and market participants should read the XinXiang Era's circulars and regulatory announcements in full including the terms and conditions of XinXiang Era's share consolidation in dealing with XinXiang Era's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of XinXiang Era's OTP-C temporary stock page (stock code 8578) on 20 October 2025. Calculation of the Adjusted Previous Closing Price will be based on XinXiang Era's closing price on 17 October 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 4/1
