Pursuant to the timetable issued by Great Eagle Holdings Limited ("Great Eagle") for the Distribution in Specie, Great Eagle's shares (stock code 41) will be marked "ex-all" on 21 October 2025, the Ex-All Date. Shareholders, investors and market participants should read the Great Eagle's regulatory announcements in full regarding the Distribution in Specie in dealing with Great Eagle's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for ex-distribution in specie ("Ex-All") and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Great Eagle's OTP-C stock page on 21 October 2025, the Ex-All Date. The unadjusted previous closing price will instead be displayed in the free text field. Calculation of the Adjusted Previous Closing Price will be based on the closing prices of Great Eagle and Langham SSU on 20 October 2025 (i.e. last cum-all trading day) and by using the following standard adjustment formula for distribution in specie generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing price of Great Eagle on the last cum-all trading day – [P x (X ÷ Y)]

where:

P = Closing price of Langham SSU (stock code 1270) on the last cum-all trading day

X = Number of Langham SSU a shareholder is entitled to receive when he/she holds Y existing shares in Great Eagle on the record date, i.e. 1 Langham SSU

Y = Number of existing shares of Great Eagle a shareholder has to hold on the record date for entitling him/herself to X Langham SSU, i.e. 15 shares

For illustration purpose, depending on the closing prices of Great Eagle and Langham SSU on 20 October 2025, the Exchange shall base on the above standard formula for distribution in specie generally to calculate and display the Adjusted Previous Closing Price on Great Eagle's OTP-C stock page on 21 October 2025 as follows:-
