Pursuant to the share consolidation timetable issued by Dragon King Group Holdings Limited ("Dragon King Group"), the share consolidation of 5 existing shares of HK\$0.10 each in Dragon King Group into 1 consolidated share of HK\$0.50 each will become effective on 21 October 2025. Shareholders, investors and market participants should read the Dragon King Group's circulars and regulatory announcements in full including the terms and conditions of Dragon King Group's share consolidation in dealing with Dragon King Group's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Dragon King Group's OTP-C temporary stock page (stock code 8579) on 21 October 2025. Calculation of the Adjusted Previous Closing Price will be based on Dragon King Group's closing price on 20 October 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 5/1
