Pursuant to the share consolidation timetable issued by Anchorstone Holdings Limited ("Anchorstone Holdings"), the share consolidation of 10 existing shares of HK\$0.01 each in Anchorstone Holdings into 1 consolidated share of HK\$0.10 each will become effective on 24 October 2025. Shareholders, investors and market participants should read the Anchorstone Holdings's circulars and regulatory announcements in full including the terms and conditions of Anchorstone Holdings's share consolidation in dealing with Anchorstone Holdings's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Anchorstone Holdings's OTP-C temporary stock page (stock code 2957) on 24 October 2025. Calculation of the Adjusted Previous Closing Price will be based on Anchorstone Holdings's closing price on 23 October 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
