Pursuant to the capital reorganisation timetable issued by China Energy Development Holdings Limited ("China Energy"), the capital reorganisation which comprises the share consolidation of 40 existing shares of HK\$0.05 each in China Energy into 1 consolidated share of HK\$2.00 each and the capital reduction of nominal value of the consolidated shares from HK\$2.00 each to HK\$0.05 each will become effective on 3 November 2025. Shareholders, investors and market participants should read the China Energy's circulars and regulatory announcements in full including the terms and conditions of China Energy's capital reorganisation in dealing with China Energy's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of China Energy's OTP-C temporary stock page (stock code 2960) on 3 November 2025. Calculation of the Adjusted Previous Closing Price will be based on China Energy's closing price on 31 October 2025 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

#### Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Capital Reorganisation becoming effective x R

#### where:

R = Ratio of Share Consolidation, i.e. 40/1
