Pursuant to the share consolidation timetable issued by Contel Technology Company Limited ("Contel Technology"), the share consolidation of 10 existing shares of HK\$0.01 each in Contel Technology into 1 consolidated share of HK\$0.1 each will become effective on 21 November 2025. Shareholders, investors and market participants should read the Contel Technology's circulars and regulatory announcements in full including the terms and conditions of Contel Technology's share consolidation in dealing with Contel Technology's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Contel Technology's OTP-C temporary stock page (stock code 2972) on 21 November 2025. Calculation of the Adjusted Previous Closing Price will be based on Contel Technology's closing price on 20 November 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
