Pursuant to the share subdivision timetable issued by Wanguo Gold Group Limited ("Wanguo Gold Group"), the share subdivision of 1 existing share of HK\$0.1 each in Wanguo Gold Group into 4 subdivided shares of HK\$0.025 each will become effective on 25 November 2025. Shareholders, investors and market participants should read the Wanguo Gold Group's circulars and regulatory announcements in full including the terms and conditions of Wanguo Gold Group's share subdivision in dealing with Wanguo Gold Group's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share subdivision and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Wanguo Gold Group's OTP-C temporary stock page (stock code 2979) on 25 November 2025. Calculation of the Adjusted Previous Closing Price will be based on Wanguo Gold Group's closing price on 24 November 2025 (i.e. the day immediately before the share subdivision becoming effective) and by using the following standard adjustment formula for share subdivision generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Subdivision becoming effective x R

where:

R = Ratio of Share Subdivision, i.e. 1/4
