Pursuant to the share consolidation timetable issued by Platt Nera International Limited ("Platt Nera"), the share consolidation of 5 existing shares of HK\$0.01 each in Platt Nera into 1 consolidated share of HK\$0.05 each will become effective on 5 December 2025. Shareholders, investors and market participants should read the Platt Nera's circulars and regulatory announcements in full including the terms and conditions of Platt Nera's share consolidation in dealing with Platt Nera's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Platt Nera's OTP-C temporary stock page (stock code 2985) on 5 December 2025. Calculation of the Adjusted Previous Closing Price will be based on Platt Nera's closing price on 4 December 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

#### Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

#### where:

R = Ratio of Share Consolidation, i.e. 5/1
