Pursuant to the share consolidation timetable issued by CMON Limited ("CMON"), the share consolidation of 35 existing shares of HK\$0.00005 each in CMON into 1 consolidated share of HK\$0.00175 each will become effective on 11 December 2025. Shareholders, investors and market participants should read the CMON's circulars and regulatory announcements in full including the terms and conditions of CMON's share consolidation in dealing with CMON's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of CMON's OTP-C temporary stock page (stock code 2991) on 11 December 2025. Calculation of the Adjusted Previous Closing Price will be based on CMON's closing price on 10 December 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 35/1
