Pursuant to the share consolidation timetable issued by FEG Holdings Corporation Limited ("FEG Holdings"), the share consolidation of 5 existing shares of HK\$0.01 each in FEG Holdings into 1 consolidated share of HK\$0.05 each will become effective on 16 December 2025. Shareholders, investors and market participants should read the FEG Holdings's circulars and regulatory announcements in full including the terms and conditions of FEG Holdings's share consolidation in dealing with FEG Holdings's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of FEG Holdings's OTP-C temporary stock page (stock code 2993) on 16 December 2025. Calculation of the Adjusted Previous Closing Price will be based on FEG Holdings's closing price on 15 December 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

#### Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

#### where:

R = Ratio of Share Consolidation, i.e. 5/1
