Pursuant to the share consolidation timetable issued by Zhengwei Group Holdings Company Limited ("Zhengwei Group"), the share consolidation of 20 existing shares of US\$0.01 each in Zhengwei Group into 1 consolidated share of US\$0.2 each will become effective on 29 December 2025. Shareholders, investors and market participants should read the Zhengwei Group's circulars and regulatory announcements in full including the terms and conditions of Zhengwei Group's share consolidation in dealing with Zhengwei Group's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Zhengwei Group's OTP-C temporary stock page (stock code 2981) on 29 December 2025. Calculation of the Adjusted Previous Closing Price will be based on Zhengwei Group's closing price on 24 December 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

### Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

#### where:

R = Ratio of Share Consolidation, i.e. 20/1
