Pursuant to the share consolidation timetable issued by Chuanglian Holdings Limited ("Chuanglian Holdings"), the share consolidation of 10 existing shares of HK\$0.01 each in Chuanglian Holdings into 1 consolidated share of HK\$0.1 each will become effective on 2 January 2026. Shareholders, investors and market participants should read the Chuanglian Holdings's circulars and regulatory announcements in full including the terms and conditions of Chuanglian Holdings's share consolidation in dealing with Chuanglian Holdings's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Chuanglian Holdings's OTP-C temporary stock page (stock code 2982) on 2 January 2026. Calculation of the Adjusted Previous Closing Price will be based on Chuanglian Holdings's closing price on 31 December 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1

For illustration purpose, depending on Chuanglian Holdings's closing price on 31 December 2025, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on Chuanglian Holdings's OTP-C temporary stock page on 2 January 2026 as follows:-
