The Stock Exchange of Hong Kong Limited (the “Exchange”) is pleased to announce the introduction of SHEIN Global Holdings Limited (“SHN”) stock options. Monthly expiry and weekly expiry contracts will be introduced on **Tuesday, 1 September 2026** (“Commencement Date”), subject to the successful listing of SHN. Exchange Participants please note SHN stock options with monthly expiries will be created under the **existing market code “143” in HKATS Matching Engine 6**, and SHN stock options with weekly expiries will be created under the **existing market code “145” in HKATS Matching Engine 6**.

The pro-forma list of stock option classes available for trading from the Commencement Date is set forth in Attachment I. For details of the contract specifications, please refer to [Appendix B: Options Contract Specifications](#) of the Operational Trading Procedures for Options Trading Exchange Participants of the Stock Exchange.

Strike Prices

In order to offer more choices for investors, 20 strikes above and below HKD 50 (which is nearest to the maximum offer price of the underlying stock) for monthly expiries and 30 strikes above and below HKD 49.5 for weekly expiries will be available for trading on the Commencement Date (see Attachment II).

Position Limits for New Stock Option Class

The position limit for SHN stock option contracts will be 50,000 open contracts in any one market direction for all expiries, combined.

Market Making for New Stock Option Class

The Exchange now invites applications for market maker permits for the new Stock Option class. Interested parties should complete Form [OP004](#) and submit the application to HKEX Client Services Department.

During the first two weeks of trading (i.e. between **Tuesday, 1 September 2026** and **Friday, 11 September 2026**, both days inclusive), the market maker obligations, in terms of the maximum bid / ask spread, will be two times of the original obligations².

Pre-launch Arrangements for New Stock Option Class

The following pre-launch arrangements will be implemented on **Monday, 31 August 2026** (i.e. one business day before the Commencement Date):

- a. option series of the monthly expiries of the new stock option class will be created under the **existing market code “143” in HKATS Matching Engine 6**; and option series of the weekly expiries of the new stock option class will be created under the **existing market code “145” in HKATS Matching Engine 6**. They will be displayed, but not tradable; and
- b. the risk parameter files (“RPF”), clearing and open interest reports on new stock option classes will be generated.

The purpose of the generation of RPF one business day before the Commencement Date is to assist Participants in estimating the margin requirements for the new stock option class trading on the Commencement Date.

Please note that the margin requirements estimated using the RPF available after the settlement process on the business day before the Commencement Date may not be the same as the actual amounts required on the Commencement Date. HKEX and its subsidiaries accept no liability whatsoever for any loss or damage arising from or in connection with the use of the information

contained in such RPF. Participants who wish to use the above-mentioned RPF are reminded to update the PC-SPAN Organisation Master File. For details, please refer to the relevant Clearing House circular to be issued in due course.

Trading Information for New Stock Option Class

The access codes of information vendors will be posted on the HKEX website in due course.

Inform Staff and Clients

Exchange Participants should notify all interested clients about the introduction of new stock options. In addition, all your staff should be fully aware of the above and should exercise caution when dealing with new stock option contracts, and when advising your clients. Please also ensure that your back office systems are operationally ready.

Investors should also be aware that some stock options have market makers signed up while others do not. Availability of market makers, depending on their sign-up, may also change from time to time. The availability of market makers will be updated on the [HKEX website](#) from time to time. Investors should exercise due caution in trading stock options without market makers and understand the liquidity risk involved. They would have to trade against other investors with opposite views when they open or close their stock option positions.
