Pursuant to the share consolidation timetable issued by China Smarter Energy Group Holdings Limited ("China Smarter Energy"), the share consolidation of 20 existing shares of HK\$0.0025 each in China Smarter Energy into 1 consolidated share of HK\$0.05 each will become effective on 10 February 2026. Shareholders, investors and market participants should read the China Smarter Energy's circulars and regulatory announcements in full including the terms and conditions of China Smarter Energy's share consolidation in dealing with China Smarter Energy's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of China Smarter Energy's OTP-C temporary stock page (stock code 2907) on 10 February 2026. Calculation of the Adjusted Previous Closing Price will be based on China Smarter Energy's closing price on 9 February 2026 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 20/1

For illustration purpose, depending on China Smarter Energy's closing price on 9 February 2026, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on China Smarter Energy's OTP-C temporary stock page on 10 February 2026 as follows:-
