Pursuant to the share consolidation timetable issued by MicroPort CardioFlow Medtech Corporation ("MicroPort CardioFlow"), the share consolidation of 5 existing shares of US\$0.000005 each in MicroPort CardioFlow into 1 consolidated share of US\$0.000025 each will become effective on 24 February 2026. Shareholders, investors and market participants should read the MicroPort CardioFlow's circulars and regulatory announcements in full including the terms and conditions of MicroPort CardioFlow's share consolidation in dealing with MicroPort CardioFlow's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of MicroPort CardioFlow's OTP-C temporary stock page (stock code 2918) on 24 February 2026. Calculation of the Adjusted Previous Closing Price will be based on MicroPort CardioFlow's closing price on 23 February 2026 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 5/1

For illustration purpose, depending on MicroPort CardioFlow's closing price on 23 February 2026, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on MicroPort CardioFlow's OTP-C temporary stock page on 24 February 2026 as follows:-
