Pursuant to the share consolidation timetable issued by Flydoo Technology Holding Limited (“Flydoo Technology”), the share consolidation of 20 existing shares of HK\$0.01 each in Flydoo Technology into 1 consolidated share of HK\$0.2 each will become effective on 6 May 2026. Shareholders, investors and market participants should read the Flydoo Technology’s circulars and regulatory announcements in full including the terms and conditions of Flydoo Technology’s share consolidation in dealing with Flydoo Technology’s shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the “PRV CLOSE” field of Flydoo Technology’s OTP-C temporary stock page (stock code 8557) on 6 May 2026. Calculation of the Adjusted Previous Closing Price will be based on Flydoo Technology’s closing price on 5 May 2026 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

#### Adjustment Formula:

Adjusted Previous Closing Price  
= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 20/1

For illustration purpose, depending on Flydoo Technology's closing price on 5 May 2026, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on Flydoo Technology's OTP-C temporary stock page on 6 May 2026 as follows:-
