Pursuant to the share consolidation timetable issued by Madison Holdings Group Limited ("Madison Holdings"), the share consolidation of 10 existing shares of HK\$0.01 each in Madison Holdings into 1 consolidated share of HK\$0.10 each will become effective on 18 May 2026. Shareholders, investors and market participants should read the Madison Holdings's circulars and regulatory announcements in full including the terms and conditions of Madison Holdings's share consolidation in dealing with Madison Holdings's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Madison Holdings's OTP-C temporary stock page (stock code 8558) on 18 May 2026. Calculation of the Adjusted Previous Closing Price will be based on Madison Holdings's closing price on 15 May 2026 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

#### Adjustment Formula:

Adjusted Previous Closing Price  
= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1

For illustration purpose, depending on Madison Holdings's closing price on 15 May 2026, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on Madison Holdings's OTP-C temporary stock page on 18 May 2026 as follows:-
