Pursuant to the rights issue timetable issued by Gaodi Holdings Limited ("Gaodi Holdings"), Gaodi Holdings's shares (stock code 1676) will be marked "ex-rights" on 15 June 2026, the Ex-Rights Date. Shareholders, investors and market participants should read the Gaodi Holdings's announcements and prospectus documents in full including the terms and conditions of the rights issue of Gaodi Holdings in dealing with Gaodi Holdings's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for ex-rights issue and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Gaodi Holdings's OTP-C stock page on 15 June 2026, the Ex-Rights Date. The unadjusted previous closing price will instead be displayed in the free text field. Calculation of the Adjusted Previous Closing Price will be based on Gaodi Holdings's closing price on 12 June 2026 (i.e. last cum-rights trading day) and by using the following standard adjustment formula for rights issue generally.

#### Adjustment Formula:

Adjusted Previous Closing Price

$$= [(Closing Price on the last cum-rights trading day \times Y) + (S \times X)] \div (X + Y)$$

where:

S = Subscription price per rights share, i.e. HK\$0.19

X = Number of rights shares a shareholder is entitled to subscribe when he/she holds Y existing shares on the record date, i.e. 1 rights share

Y = Number of existing shares a shareholder has to hold on the record date for entitling him/herself to subscribe for X rights shares, i.e. 2 shares

Note: Price adjustment for rights issue will not be made and the previous closing price will remain unchanged on ex-rights date when the subscription price is higher than the closing price of the shares on the last cum-rights trading day.

For illustration purpose, depending on Gaodi Holdings's closing price on 12 June 2026, the Exchange shall base on the above standard formula for rights issue generally to calculate and display the Adjusted Previous Closing Price on Gaodi Holdings's OTP-C stock page on 15 June 2026 as follows:-
