Pursuant to the share consolidation timetable issued by Reach New Holdings Limited (“Reach New Holdings”), the share consolidation of 20 existing shares of HK\$0.01 each in Reach New Holdings into 1 consolidated share of HK\$0.2 each will become effective on 23 June 2026. Shareholders, investors and market participants should read the Reach New Holdings’s circulars and regulatory announcements in full including the terms and conditions of Reach New Holdings’s share consolidation in dealing with Reach New Holdings’s shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the “PRV CLOSE” field of Reach New Holdings’s OTP-C temporary stock page (stock code 8566) on 23 June 2026. Calculation of the Adjusted Previous Closing Price will be based on Reach New Holdings’s closing price on 22 June 2026 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price
= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 20/1

For illustration purpose, depending on Reach New Holdings's closing price on 22 June 2026, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on Reach New Holdings's OTP-C temporary stock page on 23 June 2026 as follows:-
