Pursuant to the capital reorganisation timetable issued by Yuan Heng Gas Holdings Limited (“Yuan Heng Gas”), the capital reorganisation which comprises the share consolidation of 20 existing shares of HK\$0.1 each in Yuan Heng Gas into 1 consolidated share of HK\$2.0 each and the capital reduction of par value of the consolidated shares from HK\$2.0 each to HK\$0.1 each will become effective on 6 July 2026. Shareholders, investors and market participants should read the Yuan Heng Gas’s circulars and regulatory announcements in full including the terms and conditions of Yuan Heng Gas’s capital reorganisation in dealing with Yuan Heng Gas’s shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the “PRV CLOSE” field of Yuan Heng Gas’s OTP-C temporary stock page (stock code 2977) on 6 July 2026. Calculation of the Adjusted Previous Closing Price will be based on Yuan Heng Gas’s closing price on 3 July 2026 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

#### Adjustment Formula:

Adjusted Previous Closing Price  
= Closing Price on the day immediately before Capital Reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 20/1

For illustration purpose, depending on Yuan Heng Gas's closing price on 3 July 2026, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on Yuan Heng Gas's OTP-C temporary stock page on 6 July 2026 as follows:-
