Pursuant to the capital reorganisation timetable issued by Good Fellow Healthcare Holdings Limited ("Good Fellow Healthcare"), the capital reorganisation which comprises the share consolidation of 5 existing shares of HK\$0.05 each in Good Fellow Healthcare into 1 consolidated share of HK\$0.25 each and the capital reduction of par value of the consolidated shares from HK\$0.25 each to HK\$0.01 each will become effective on 15 July 2026. Shareholders, investors and market participants should read the Good Fellow Healthcare's circulars and regulatory announcements in full including the terms and conditions of Good Fellow Healthcare's capital reorganisation in dealing with Good Fellow Healthcare's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Good Fellow Healthcare's OTP-C temporary stock page (stock code 8567) on 15 July 2026. Calculation of the Adjusted Previous Closing Price will be based on Good Fellow Healthcare's closing price on 14 July 2026 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Capital Reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 5/1
