Pursuant to the share consolidation timetable issued by DT Capital Limited ("DT Capital"), the share consolidation of 15 existing shares of HK\$0.01 each in DT Capital into 1 consolidated share of HK\$0.15 each will become effective on 20 July 2026. Shareholders, investors and market participants should read the DT Capital's circulars and regulatory announcements in full including the terms and conditions of DT Capital's share consolidation in dealing with DT Capital's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of DT Capital's OTP-C temporary stock page (stock code 2990) on 20 July 2026. Calculation of the Adjusted Previous Closing Price will be based on DT Capital's closing price on 17 July 2026 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 15/1

For illustration purpose, depending on DT Capital's closing price on 17 July 2026, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on DT Capital's OTP-C temporary stock page on 20 July 2026 as follows:-
