Pursuant to the share consolidation timetable issued by Beijing Sports and Entertainment Industry Group Limited ("Beijing Sports"), the share consolidation of 10 existing shares of HK\$0.005 each in Beijing Sports into 1 consolidated share of HK\$0.05 each will become effective on 24 August 2026. Shareholders, investors and market participants should read the Beijing Sports's circulars and regulatory announcements in full including the terms and conditions of Beijing Sports's share consolidation in dealing with Beijing Sports's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Beijing Sports's OTP-C temporary stock page (stock code 2908) on 24 August 2026. Calculation of the Adjusted Previous Closing Price will be based on Beijing Sports's closing price on 21 August 2026 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1

For illustration purpose, depending on Beijing Sports's closing price on 21 August 2026, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on Beijing Sports's OTP-C temporary stock page on 24 August 2026 as follows:-
