Pursuant to the share consolidation timetable issued by Jintai Energy Holdings Limited ("Jintai Energy Holdings"), the share consolidation of 20 existing shares of HK\$0.00125 each in Jintai Energy Holdings into 1 consolidated share of HK\$0.025 each will become effective on 15 September 2026. Shareholders, investors and market participants should read the Jintai Energy Holdings's circulars and regulatory announcements in full including the terms and conditions of Jintai Energy Holdings's share consolidation in dealing with Jintai Energy Holdings's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Jintai Energy Holdings's OTP-C temporary stock page (stock code 2925) on 15 September 2026. Calculation of the Adjusted Previous Closing Price will be based on Jintai Energy Holdings's closing price on 14 September 2026 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 20/1
