Please be advised that The SEHK Options Clearing House Limited (SEOCH) has determined to increase the haircut rate of HSI constituent stocks after the close of business on <u>1 December 2022</u> as follows:

HSI Constituent Stock	Haircut Rate	
	Current	New
Country Garden Holdings Co. Ltd.	40%	43%
Country Garden Services Holdings Co. Ltd.	31%	33%

This haircut rate shall be applied to discount the value of the above stock collateral in covering the margin requirements of SEOCH participants' house accounts. Participants should make necessary funding arrangements to cover any shortfall to their margin requirements resulting from the increase in the haircut rate.
