Subject: Change of Authentication for CCMS Terminal – Official Launch of Two-Factor Authentication Reminder Enquiry: DCASS Hotline : 2979 7222/ E-mail : clearingpsd@hkex.com.hk

Reference is made to the circular dated 24 May 2023 (Reference: <u>CD/OEC/SEOCH/138/2023</u>). The SEHK Options Clearing House Limited (SEOCH) will officially launch the Two-Factor Authentication (2FA) on 12 June 2023 (Monday), where 2FA will replace the existing smartcard for the terminal access to CCMS.

Clearing Participants (CPs) are reminded to note the following key tasks upon the official launch of 2FA and make all necessary arrangements where appropriate.

(1) Post-Release Connectivity Test on 10 June 2023 (Saturday)

CPs should continue to access CCMS by using their existing connectivity configuration. In case CPs would like to conduct a connectivity verification, a post-release connectivity test will be available from 18:00 – 20:00 and 22:00 – 23:00 on 10 June 2023 (Saturday) for such purpose. Interested CPs should register for the connectivity test via Event section in Client Connect on <u>HKEX Access Management Portal</u> on or before 9 June 2023 (Friday).

(2) 2FA Initialization from 12 June 2023 (Monday)

Users and Delegated Administrators (DAs) shall access to CCMS Terminal or Security Management Function (DMS) to (i) setup password and; (ii) setup OTP channel (i.e. by mobile application or email). To avoid any hiccups in accessing to CCMS Terminal or DMS for daily operations, it is suggested to reserve **at least 30 minutes** to complete the 2FA initialization before the first operational task of the day.



The "Information Package for Launch of 2FA" is now available on <u>HKEX website</u>. CPs should read through such information package and make all necessary arrangements. A separate SEOCH circular will be issued for the relevant amendments to the Options Clearing Rules and the Operational Clearing Procedures of SEOCH.
