Invitation to Orion Derivatives Platform (“ODP”) Town Hall – 6 August 2025

Hong Kong Exchanges and Clearing Limited (“HKEX”) is undertaking a strategic initiative to develop the ODP, a derivatives platform with enhanced trading, clearing and risk management capabilities. Early and ongoing engagement with market participants is critical to ensure smooth transition.

HKEX is pleased to invite Clearing Participants (“CPs”) of The SEHK Options Clearing House Limited (“SEOCH”) to the first ODP Town Hall session. This session will provide an overview of ODP, including its development timeline, enhanced functionalities, and next steps for market engagement.
