Subject: 2026 Annual Attestation and Inspection Programme

As part of our continuing efforts to promote the compliance culture of our marketplace, we will commence the 2026 Annual Attestation and Inspection Programme (the “**Programme**”) shortly. The Programme will focus on participants’ compliance with the relevant rules and regulations, comprising of two core components: (1) self-attestation of compliance by participants (through a questionnaire); and (2) on-site inspection of selected participants. Details of the Programme can be found on the [HKEX Rule Enforcement webpage](#).

PROGRAMME’S PRIORITY AREAS

The 2026 Programme will prioritise the following areas:

- Trading and Deviated Price Risk Controls:** Risk controls (other than Exchange-provided system) implemented on Exchange Participant’s trading systems, measures to prevent deviated price execution and procedures to handle Error Trade claims (*applicable to HKFE Participants and SEHK Stock Options Exchange Participants*).
- Risk Management:** Practices in place to identify, assess, monitor and mitigate various areas of risk such as credit, liquidity, operational, market and financial (*applicable to Clearing Participants*¹).

The self-attestation compliance questionnaire will cover the Hong Kong Investor Identification Regime (*applicable to SEHK Participants*).
