Remarks :

- # "Market" is only applicable to relevant CCASS reports. CCASS supports Multiple Market Infrastructure, and produces market-specific reports for users' reference. Currently there are three markets - HONG KONG market with market code as "HKMK", Shanghai securities market with market code as "MAMK" and Shenzhen securities market with market code as "SZMK". However, some processes apply to all markets (global processes, e.g., collateralisation) and thus do not have relevant market-specific reports. CCMS functions are classified as global processes and therefore all CCMS reports are classified as "GLOBAL" reports.
- @ "Y" indicates that the report is available for downloading / printing via Overnight Report Distribution Function (ONRD)
 "N" indicates that the report is NOT available for downloading / printing via Overnight Report Distribution Function, Participants should retrieve such report via Report Download Function.
