

Guidance Notes to Applicant for Becoming a CCASS Designated Bank

1. Conditions for Becoming CCASS Designated Bank

To become a Designated Bank of the Central Clearing and Settlement System ("CCASS") operated by Hong Kong Securities Clearing Company Limited ("HKSCC"), the applicant must fulfill the following conditions, namely:

- a. be a licensed bank or a restricted licence bank under the Hong Kong Banking Ordinance;
- b. agrees to install a CCASS Terminal maintaining electronic linkage with CCASS and HKSCC;
- c. has completed the necessary set-up and testing (with the clearing house for the relevant Eligible Currency) to be identified as a Designated Bank for the purpose of receiving the daily CCASS money settlement information;
- d. where the applicant agrees to provide money settlement of CCASS transactions via CHATS Payment Instructions (CPIs), it has completed the necessary technical set-up as prescribed by the clearing house for the relevant Eligible Currency from time to time for effecting CCASS-related Clearing House Automated Transfer System (CHATS) payment;
- e. in relation to its application to act as Designated Bank for Participants (other than Investor Participants), it has duly completed and submitted the required application documents, including an undertaking in favour of HKSCC in the form prescribed by HKSCC, by which it undertakes to issue to HKSCC a confirmation, by no later than the times as stipulated in such undertaking through its CCASS Terminal on all Bank Business Days stating details of payment under any Direct Debit Instructions ("DCIs"), Direct Credit Instructions ("PCIs") or Electronic Payment Instructions ("EPIs") drawn on or paid to and rejected by it;
- f. in relation to its application for acting as Designated Bank for Investor Participants, it has duly completed and submitted the required application documents, including an undertaking in favour of HKSCC in the form prescribed by HKSCC, by which it undertakes to issue to HKSCC a confirmation by no later than the time as stipulated in such undertaking through its CCASS Terminal on all Bank Business Days stating details of any DDIs and debit EPIs, which are generated from ISI Transactions to be settled on a Delivery versus Payment (DVP) basis with the application of on hold mechanism, drawn on and rejected by it.

2. <u>Where to Submit Application</u>

Applicant should complete and submit by post or by hand the prescribed application documents (see Notes 3 and 4 below) to Participant Services, Cash Trading of Hong Kong Exchanges and Clearing Limited ("HKEX") at 6/F, Two Exchange Square, 8 Connaught Place, Central, Hong Kong. (For enquiry, please contact CCASS Hotline: 2979-7111)

3. Application Documents to be Submitted

Applicant must complete and submit the following documents:

- a. CCASS Designated Bank Application Form;
- b. Selection of Money Settlement Currency Questionnaire;
- c. Such Undertaking(s) as appropriate (see Note 1 above).

4. Other Documents Required

A copy of each of the following documents duly certified by any one of the applicant's directors, company secretary or a notary public, a solicitor or professional accountant must be submitted:

- a. For applicant incorporated under the Companies Ordinance of Hong Kong
 - i. Business Registration Certificate;
 - ii. Certificate of Registration as licensed bank or a restricted licence bank in Hong Kong, as appropriate;
 - iii. Certified True Extract of Minutes of the Board of Directors authorising the application for admission as a Designated Bank of HKSCC (please refer to Attachment 1), or such other equivalent document; and
- b. For applicant incorporated outside Hong Kong and registered as a non-Hong Kong company under Part XI of the Companies Ordinance of Hong Kong
 - i. Business Registration Certificate (issued in Hong Kong);
 - ii. Certificate of Registration as licensed bank or a restricted licence bank in Hong Kong, as appropriate;
 - iii. Certified True Extract of Minutes of the Board of Directors authorising the application for admission as a Designated Bank of HKSCC (please refer to Attachment 1), or such other equivalent document; and

(Applicant should also complete and return various documents and forms to HKSCC in relation to its operations in the Central Clearing and Settlement System ("CCASS"). Please refer to Attachment 2 for the list of the relevant documents and forms.)
