<b>Report Name</b>	:	<i>SI Status Report</i>
<b>Purpose</b>	:	The <i>SI Status Report</i> lists pending SIs which remain unauthorised, SIs which remain unmatched at the end of the business day and SIs that are matched or matched on-hold but not yet due for settlement on the coming settlement day. Follow-up actions for pending and unmatched SIs can be made if necessary. This report has five sections: Pending SI, Unmatched SI, Matched SI, Matched On-hold SI and Payment Validated SI. SI status of Hong Kong market shares, Shanghai market shares and Shenzhen market shares are shown in separate reports.
<b>Section Content</b>	:	<p><u>I. PENDING SI</u></p> <p>Details of pending SIs which remain unauthorised as of the end of the business day.</p> <p><u>II. UNMATCHED SI</u></p> <p>Details of SIs which remain unmatched as of the end of the business day.</p> <p><u>III. MATCHED SI</u> (pending settlement)</p> <p>Details of SIs that are matched but are not yet due for settlement on the coming settlement day.</p> <p><u>IIIa. MATCHED ON-HOLD SI</u> (pending settlement)</p> <p>Details of SIs that are matched on-hold but are not yet due for settlement on the coming settlement day.</p> <p><u>IV. PAYMENT VALIDATED SI</u></p> <p>Details of SIs to be settled on a RDP basis which CHATS payments were validated and accepted by CCASS while confirmation of money settlement was not received from the Clearing House of HKAB.</p> <p>Only Section I to Section IIIa are applicable to SI Status Report of Shanghai market and Shenzhen market.</p>
<b>Time available</b>	:	On each business day from the time when the report download function is available.
<b>Frequency</b>	:	Daily
