Purpose	:	<p>The <i>Statement of Stock Movement (By Stock) Report</i> lists the day's account movements by stock, then by account (clearing and other segregated accounts) arising from settlement of CNS positions, SI and IT, deposits, withdrawals, account transfer (ATI, STI and Mass ATI/STI), entitlements, benefit claims/unclaims, stock splitting / merging, etc.</p> <p>The opening and closing balance (includes those accounts which have no movement during the day) and all inward / outward movements for each account of each stock are shown. This provides an audit trail for all stock movements within the accounts.</p> <p>In general, account movements are listed by stocks in chronological order. Stocks and accounts with no movement activities are not included in the report.</p> <p>Stock movement of Hong Kong market shares, Shanghai market shares and Shenzhen market shares are shown in separate reports.</p>
