This is to ensure the HKEX Hosting Subscriber's obligations under the clause 4.3(b) of Hosting Services Subscription Agreement is an essential measure in place to maintain alternative means of access to the trading, clearing, and settlement systems and/or the market data dissemination systems of the HKEX Group.

The objective of the Rehearsal is to also enable HKEX Hosting Subscribers and related parties to familiarize themselves with contingency procedures and related operational matters for their business continuity and disaster recovery arrangements under emergency situations.
