The regular system recovery rehearsal (the “Rehearsal”) for Hosting Subscribers will be conducted on Saturday, 19 July 2025. Reference is made to the following HKEX circulars:

This is to ensure the HKEX Hosting Subscriber’s obligations under the clause 4.3(b) of Hosting Services Subscription Agreement is an essential measure in place to maintain alternative means of access to the trading, clearing, and settlement systems and/or the market data dissemination systems of the HKEX Group.

The objective of the Rehearsal is to also enable HKEX Hosting Subscribers and related parties to familiarise themselves with contingency procedures and related operational matters for their business continuity and disaster recovery arrangements under emergency situations.
