Dear SEHK and HKFE Exchange Participants

HKEx Hosting Services is pleased to introduce an Entry Level Package to facilitate Exchange Participants with less complex technical and footprint requirements to use its hosting services.

The Entry Level Package is composed of the following bundled services:

<i>Entry Level Package</i>	<i>Non-Recurrent Fee</i>	<i>Monthly Recurrent Fee^(Note)</i>
Half Rack with 2kVA Power	HK\$15,000	HK\$17,500
HKEx Services Network – Pair of 100M Port (Active + Backup)	HK\$10,000	HK\$6,000
One Cross Connect	HK\$ 2,000	HK\$1,500
Total	HK\$27,000	HK\$25,000

Note:

- For SEHK and HKFE Exchange Participants who subscribe for the Entry Level Package for a 24-month contract term, 7 months of Monthly Recurrent Fee will be waived
- For any SEHK Exchange Participant who is not an existing Broker Supplied System (BSS) user, an additional 3 months of Monthly Recurrent Fee will be waived if the SEHK Exchange Participant becomes a BSS user (as verified by SEHK) within twelve months of the commencement of services under its Entry Level Package subscription.

SEHK and HKFE Exchange Participants who wish to subscribe for the Entry Level Package shall make an application to HKEx Hosting Services following its standard application procedures. The following eligibility criteria and conditions shall apply in respect of the Entry Level Package:

- The offer is only applicable to SEHK and HKFE Exchange Participants
- During the initial contract term of 24 months, if an SEHK or HKFE Exchange Participant wishes to order extra rack space or power in addition to that comprised in the Entry Level Package, the fee waivers mentioned above shall no longer apply and no such order will be allowed unless the SEHK or HKFE Exchange Participant pays to HKEx Hosting Services all fees waived under the Entry Level Package
- Standard fees shall apply with no fee waivers in respect of orders for all other types of services offered by HKEx Hosting Services
- Subject to contract on HKEx Hosting Services' standard terms
- Subject to availability
- Offer valid till 31 December 2012.
