Guiding Note on Enterprise Data Package

Securities and Derivatives Market Data

(For Real-time Market Data Vendors)

PURPOSE

HKEX Information Services Limited (“HKEX-IS”) introduced the Enterprise Data Package (“the Package”) to provide a fixed fee option to market data vendors (“Vendors”) to facilitate retail trading in the Hong Kong market.

This document aims to provide guidance to HKEX-IS licensed real-time Vendors who subscribe to the Package under the Market Data Vendor Licence.

DETAILS

Application

1. Vendors who wish to apply for the Package are required to submit the Service Application Form (“Form A3”) for consideration and approval. Upon approval, the Package will be added to Schedule 4 Memorandum of Permitted Purpose (“MOPP”) of the Market Data Vendor Licence Agreement (“Vendor Agreement”).

Eligibility

2. The Package is only applicable to Exchange Participants of the Stock Exchange of Hong Kong or Hong Kong Futures Exchange (“EPs”) or brokers that are registered with a regulatory body for brokerage service of securities or futures/options trading.
3. Vendors are restricted to market data vendor licensee or licensee's related company approved under Schedule 2 of the Vendor Agreement, subject to the applicable Redistribution Fee, Connection Fee (for direct connection only) and Subscriber Fees. Vendor's Third Party Service client is not eligible for the Package.
4. Upon commencement of the Package, Vendors are required to provide total monthly trading turnover statistics in value by subscribers' regions and name(s) of the relevant EP through which they trade for Hong Kong market as a condition to join the Package.
5. Vendors should provide the vendor service under the Package according to the Scope of Service specified in this document.

6. Scope of Service and Fee Structure

Vendors who wish to provide vendor services in Chinese Mainland may subscribe to the Market Data Packages for the Mainland Market.

Reporting Requirements

7. Vendors are required to use the standard template of the Monthly Subscriber Report sent from HKEX-IS (China) for the particular month and report the total number of Subscriber units. An Excel template of the Monthly Subscriber Report will be provided to Vendors.
8. Vendors are required to maintain complete and accurate records related to the calculation of Subscriber Fees for audit purpose as per clause 5.6 of the Market Data Vendor Licence Agreement.
9. All Vendors must obtain necessary consent from Subscribers to ensure compliance with the requirements of Personal Data (Privacy) Ordinance of the Laws of Hong Kong as well as the provisions of the Vendor Agreement (including but not limited to clauses 4.6, 5.6, 5.7 and 5.8) which relate to Subscriber information and records that could be accessed by HKEX-IS (China).

General Conditions

10. HKEX-IS (China) shall have the discretion over the approval or rejection of Vendors' application for the Package.
11. HKEX-IS (China) reserves the right to remove any vendor service that is believed to have violated the conditions of the Package from the MOPP of the Licence Agreement and reserves the right to amend the conditions of the Package at any time.
