02 | Overview of the Enhancement

What is the Enhancement?


- The first service release for Orion Cash Platform (“OCP”) is the Enhancement of CCASS and CCMS Report Download.
- HKEX aims to launch the Secure File Transfer Protocol¹ (“SFTP”) service via the Report Access Platform (“RAP”) as the new download channel for CCASS and CCMS, replacing report retrieval via the CCASS/ CCMS Terminal.

Existing Arrangement – CCASS/ CCMS Terminal

 Stakeholders can manually log in to the web-based CCASS/CCMS Terminal to **view, select, and download or print reports**

 Specific Participants can **pre-define a designated download path** for the reports and **subscribe to the overnight report distribution**

Enhanced Arrangement - RAP

 Stakeholders will be **required to retrieve the CCASS/ CCMS reports via SFTP** through the RAP

- The migration to RAP is crucial and **compulsory** for all Stakeholders.
- Through the Enhancement, the “Report Download”, “Report Profile Maintenance” and “Overnight Report Download” functions in the CCASS / CCMS Terminal are targeted to be obsoleted after a 3-months parallel run period.

The implementation of CCASS and CCMS reports via RAP is targeted for the 2nd half of July 2025, subject to regulatory approval.

 *Note:*
1. SFTP is a network protocol that enables secure and encrypted file transfers over remote systems. Stakeholders should source their own software to support the use of SFTP.

02 | Overview of the Enhancement

Why is this Enhancement being made?



Simplifies Report Access Process

The process of accessing reports, which currently happens via web-based terminals, will be simplified.



Heightens security of data transmission

Ensure secure file transfer through SFTP between HKEX clearing houses and external parties.



Streamlines Report Retrieval Channel

Bring alignment to the retrieval channels for various reports (e.g. DCASS, VaR) generated by HKEX clearing houses.



Improves operational efficiency

Encourage machine-to-machine automated operational workflows; Alleviate the burden of manual processes and increase operational efficiency.

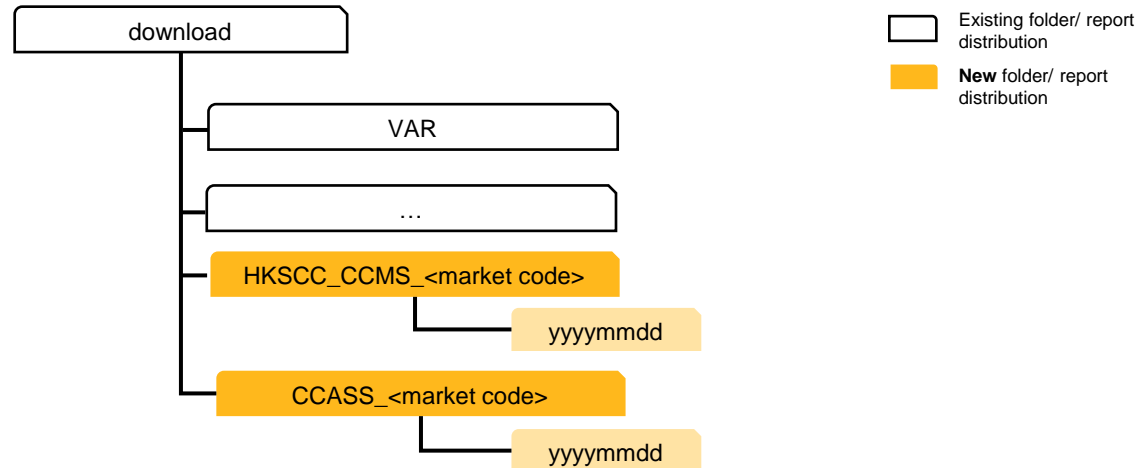
03 | Scope of the Enhancement – for HKSCC Participants

What is it being offered?

Currently, some Clearing Participants are retrieving VaR Platform reports from RAP. The RAP will be enhanced as follows for Participants:

- Allow access for Custodian Participants, Stock Lender Participants, and Stock Pledgee Participants.
- A **new folder structure** will be provided for HKSCC Participants to retrieve CCASS and CCMS reports.

e.g. CB99999001

03 | Scope of the Enhancement – for HKSCC Participants

What is it being offered?

- HKSCC Participants can **configure their RAP accounts with three types of report access** based on their needs.
 - ✓ CCASS, CCMS and VaR Platform (if applicable) reports;
 - ✓ CCASS and CCMS reports; or
 - ✓ VaR Platform (if applicable) reports only
- An **increase** in the allowed **number of RAP user accounts and workstations per RAP account** that HKSCC Participants can apply for.

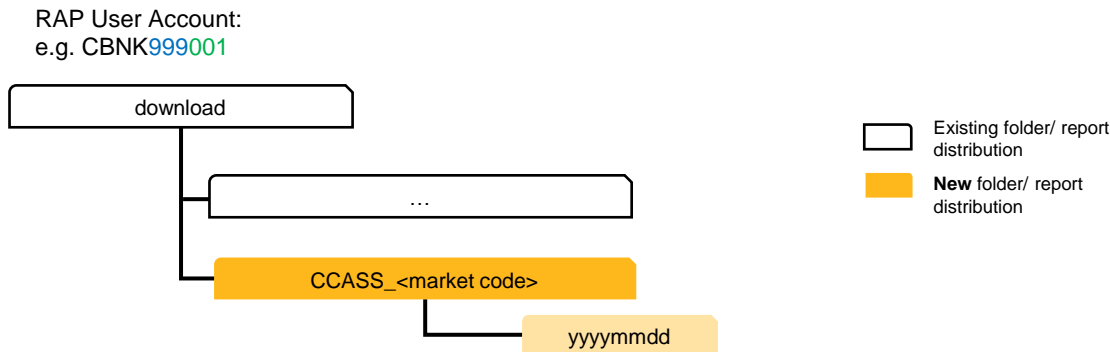

What is it being offered?

The RAP will be enhanced to allow DBs to access and retrieve CCASS reports using the following folder structure:



- The allowed number of RAP user accounts and workstations per RAP account that DBs can apply for are as follows:

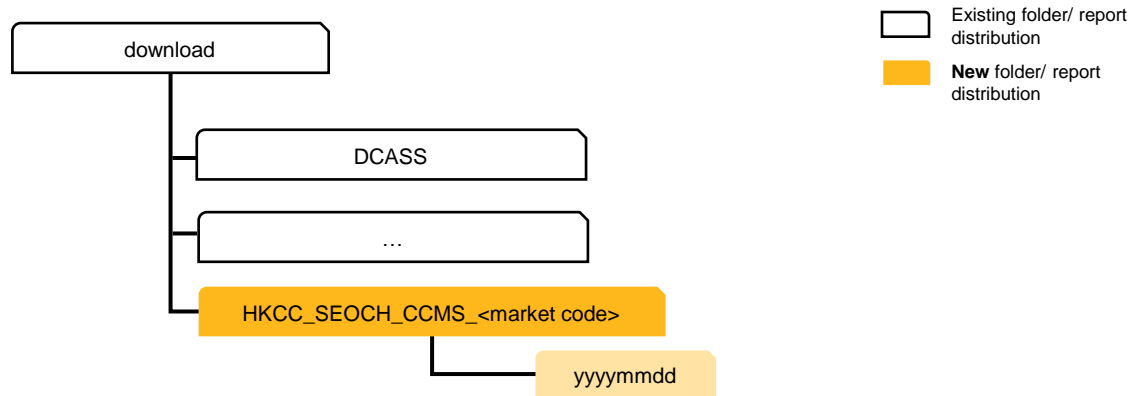

What is it being offered?

The Report Retrieval Solution will be renamed as Report Access Platform (RAP), effective from the implementation of the Enhancement. The RAP will be enhanced as follows for HKCC & SEOCH Participants:

- A **new folder structure** will be provided for HKCC and SEOCH Participants to retrieve CCMS reports.

What is it being offered?

- HKCC and SEOCH Participants can **configure their RAP accounts with three types of report access** based on their needs.
 - ✓ CCMS and DCASS reports;
 - ✓ CCMS reports only; or
 - ✓ DCASS reports only
- An **increase** in the allowed number of **RAP user accounts and workstations per RAP account** that HKCC and SEOCH Participants can apply for.

04 | Preparation Arrangements

What are Secure Shell (SSH) keys?

RAP adopts SSH public-key authentication. For each RAP user account, Stakeholders should generate a pair of SSH private and public keys, as well as a public key fingerprint.

Each SSH key pair includes two keys:

- Public Key – to be registered on RAP
- Private Key – to be kept by Stakeholders and used on RAP server or client workstation to log in to RAP

RAP only accepts RSA public keys with key length of 2048 bit and 4096 bits in SSH2 format, e.g.

04 | Preparation Arrangements – For HKSCC Participants and Designated Banks

How to prepare for registering new/ additional RAP user account(s) and workstation(s)?

Before submitting the information through e-service, TechS 8, below are the preparations for registering a new RAP user account:

- ✓ Participants and DBs should generate a pair of **SSH public and private keys** for each user account. Please ensure that private keys are **NOT** included in the zip file sent to Client Connect.



Identity of Stakeholders	File Name of the Public Key
Participants of HKSCC other than Investor Participants	CXnnnnn001.pub (for RAP user account CXnnnnn001), Xnnnnn refers to the Participant ID
Designated Banks of HKSCC	CBNKnnn001.pub (for RAP user account CBNKnnn001), nnn refers to the bank code.

- ✓ The RAP is only accessible from the Securities and Derivatives Network (SDNet) which is designated for connection to CCASS. IP addresses of RAP server or client workstations must fall within the same subnet of SDNet for HKSCC.

04 | Preparation Arrangements – For HKCC & SEOCH Participants

How to prepare for registering new/ additional RAP user account(s) and workstation(s)?

Before submitting the information through e-service, TechS 8, below are the preparations for registering a new RAP user account:

- Participants should generate a pair of **SSH public and private keys** for each user account. Please ensure that private keys are **NOT** included in the zip file sent to Client Connect.



Public Key file name (DCXXX001.pub; DCXXX002.pub; DCXXX003.pub; DCXXX004.pub)

- ✓ The RAP is only accessible from the Securities and Derivatives Network/2 (SDNet/2) or HKEX Service Network (HSN). IP addresses of RAP server or client workstations must be within the same subnet (first 3 octets) of SDNet/2 or HSN.

What is the use of e-Service TechS 8 in the Enhancement?



What is TechS 8?

- The e-Service TechS 8 on Client Connect¹ is designed for HKSCC, HKCC, SEOCH Participant, and HKSCC Designated Banks to **register** or **maintain** Report Access Platform (RAP) user accounts.
- This e-Service is available 24 hours a day, except during regular system maintenance.
- This e-Service will be updated on 12 May 2025 to support the Enhancement.



What is the key information you need to provide in TechS 8?

- ✓ Public key generated from a pair of Secure Shell (SSH) keys
- ✓ SSH public key fingerprint
- ✓ IP addresses for the designated RAP server or client workstations
- ✓ Types of reports or data files to be configured for the account

Stakeholders SHOULD NOT submit their private keys in Client Connect and shall keep their private keys confidential.

1. Stakeholders can visit [Client Connect](#) for RAP user accounts registration and maintenance.

04 | Preparation Arrangements

When can we apply new/ additional user account(s)?

New or Additional RAP User Account Registration

- The Stakeholders may submit new registration requests for facilitating the Enhancement through the **e-Service, TECHS 8** in Client Connect **starting from 12 May 2025**.
- For new accounts to be effective before the optional Practice Session, the Stakeholders must submit new registration requests with remark “for CCASS and CCMS Reports Practice Session” on/ before 30 May 2025.
- For new accounts to be effective before the rollout of the Enhancement, the Stakeholders must submit new registration requests with remark “for the rollout of CCASS and CCMS Reports Enhancement” on/ before 20 Jun 2025.

How can we prepare the Enhancement for the existing RAP user accounts?

New CCASS and CCMS Report Folders Automatically Enabled for Stakeholders

- Under this arrangement, the Stakeholders with the existing RAP user accounts will be **automatically enabled** to receive CCASS and CCMS reports upon the rollout of the enhancement.
- If the Stakeholders do not wish the existing RAP user accounts to be enabled for CCASS and/ or CCMS report retrieval, please return the feedback through the questionnaires via “Event” section in Client Connect **on/ before 30 May 2025**.

Maintenance of RAP User Accounts e.g. update of workstations

- The Stakeholders may submit maintenance requests through the **e-Service, TECHS 8** for facilitating the Enhancement in Client Connect **starting from 12 May 2025**.
- For maintenance requests to be effective before the optional Practice Session, the Stakeholders must submit maintenance requests with remark “for CCASS and CCMS Reports Practice Session” **on/ before 30 May 2025**.
- For maintenance to be effective before the rollout of the Enhancement, the Stakeholders must submit maintenance requests with remark “for the rollout of CCASS and CCMS Reports Enhancement” **on/ before 20 Jun 2025**.

The Stakeholders are reminded to renew the existing RAP user accounts’ Secure Shell (SSH) key before they expires (i.e. every two years).



Technical Set-up and Tips



05 | Technical Set-up

How to access RAP via SFTP Facility?

Upon registration of public keys and IP addresses, the Stakeholders can access HKEX RAP with the assigned user accounts via one of the registered RAP server or client workstations.

- Under normal circumstances, Stakeholders should connect to RAP using the HKEX Primary data centre RAP IP addresses.
- In the event of a contingency requiring RAP activation in its HKEX secondary data centre, the RAP connection will be interrupted. Once RAP service is resumed, Stakeholders will need to change the IP address for RAP connection to its HKEX secondary data centre:

The **same** as existing for accessing VaR Platform reports

The **same** as existing for accessing DCASS reports

- Participants are not required to perform additional technical setup to connect to RAP if they already have access to VaR and DCASS reports via SFTP.



05 | Technical Set-up

Technical Tips



Concurrent login is not allowed

- A user account is allowed to log on through up to 4 pre-registered IP address(es). However, concurrent login is not allowed.



Self-service Renewal of Public Keys

- Stakeholders are required to renew their public keys at least **every 2 years**. Stakeholders should re-register their keys with HKEX immediately if the corresponding private keys are being compromised.
- After generating new SSH public and private keys, Stakeholders should renew their SSH public keys with HKEX by submitting the keys to the /key_management/publickey folder. After submission, an Acknowledgement or Rejection file will be generated and available for retrieval in the /key_management/publickey folder.
- Public Key Expiry Warning File (“SSHKeyExpireWarning.txt”) will appear in /key_management/publickey folder if the public key is going to expire within 14 days.



RAP User Account Format

- RAP user accounts are CASE-SENSITIVE, and Stakeholders should input their RAP user accounts in CAPITAL LETTERS.

Technical Tips



Reports Format

- Reports/ data images are formatted into **zip** files. These files should be decompressed to extract the reports, which are identical to the reports currently downloaded via CCASS Terminal.



File Retention Period

- All CCASS and CCMS reports and data files will be available via RAP for retrieval for **10** calendar days after generation. Stakeholders should retrieve and save their reports/files in a timely manner.
