Alternatively, Exchange Participant can use Client Connect (https://connect.hkex.com.hk/) to submit this Requisition Form to HKEX.

^{*}If an EP wishes not to participate in the Rollout Test, EP can apply for exemption and is required to complete "Section III - Undertaking by Exchange Participant" on the form. Please note that the aforesaid exemption from conducting rollout test is not applicable to Market Making OCG-C session.

4. "Existing SDNet/2 or HSN" means the dual circuits to be connected to the applied OCG-C/ Drop-Copy session(s) are already in production. The aforementioned dual circuits include those directly subscribed by an EP from SDNet/2 network provider/ HKEX Hosting Service Network, or sharing with other EP(s) via the subscription from SDNet/2 ASP or HSN Virtual Port Service.
