**Subject: 2025 Annual Attestation and Inspection Programme – Self-attestation of Compliance Questionnaire**

Reference is made to the circular (Ref. No.: MSM/003/2025) dated 1 April 2025 regarding the Annual Attestation and Inspection Programme 2025 (the “Programme”).

Under the Programme, all Participants<sup>1</sup> are required to submit a duly completed Self-attestation of Compliance Questionnaire (the “Questionnaire”) via the Electronic Communication Platform (the “ECP”) at <https://ecp2.hkex.com.hk/>.

The Questionnaire covers the two priority areas of the Programme i.e. (1) China Connect Rules and (2) Risk Management, and Prescribed Risk Controls. All Participants are required to complete and return the Questionnaire by **1 August 2025**.

Participants are reminded of their obligations under the relevant rules<sup>2</sup> to complete and return the Questionnaire to the Exchange by the specified deadline. Any late or incomplete submission will be taken seriously and may result in disciplinary actions in accordance with the relevant rules and regulations.
