Following the Briefing Sessions on the HKATS and DCASS System Upgrade ("HKATS/DCASS Upgrade") held in June 2017, we would like to provide you herewith more information about the Market Data Solutions offered by HKEX for the HKATS/DCASS Upgrade.

New Feed Package under HKEX Orion Market Data Platform – Derivatives Market (OMD-D)

As introduced at the HKATS/DCASS Briefing Sessions, a new feed package, namely Derivatives Lite ("D-Lite"), under OMD-D will be offered to Participants of Hong Kong Futures Exchange Limited and Participants of The Stock Exchange of Hong Kong Limited trading Stock Options (collectively Exchange Participants, or EPs) with a flat fee of \$2,000 per month (subject to approval). Please find enclosed the enrolment form for D-Lite. EPs planning to receive market data from D-Lite upon the service rollout in April 2018 are required to complete and return the form to HKEX Information Services Limited ("HKEX-IS") on or before 31 October 2017. Companies who would like to become Application Service Providers and provide D-Lite to EPs may notify HKEX-IS at MarketData@hkex.com.hk for arrangement.

Please also find enclosed the OMD-D Interface Specification and the Developers Guide of D-Lite for your reference.
