Subject: **Practice Sessions on the Pre-Trade Risk Management (PTRM) System in Derivatives Market**

Reference is made to the circular dated 2 November 2015 (Ref. [MO/DT/148/15](#)) issued by HKFE. With the implementation of the Pre-Trade Risk Management (PTRM) System, Clearing Participants must set prescribed risk controls for themselves (as Exchange Participants) and General Clearing Participants must set prescribed risk controls for each Non-Clearing Participant for whom they clear.

To facilitate Clearing Participants to familiarize with the PTRM System, HKEx will conduct practice sessions from 16 November 2015 to 8 January 2016 to explain the features in the PTRM System. Details of the practice sessions are as follows:
