# 1. Overview

## 1.1. Background

This document serves as a technical reference guide for Hong Kong Investor Identification Regime (HKIDR) interface files exchange through the “Electronic Communication Platform 2.0” (ECP) provided by HKEX.

The document covers the following areas:

- Operation of HKIDR Interface Files Exchange;
- Access to ECP Web Interface and ECP SFTP Interface;
- Self-service provided on registration for ECP SFTP Interface access that includes public key and remote IP address maintenance;
- Connectivity details of Production and End-To-End Testing Environment of ECP for HKIDR interface file submission

Exchange Participants (EPs) and non-EP Relevant Regulated Intermediaries should also refer to the “Investor Identification Regime at Trading Level for the Securities Market (HKIDR) File Interface Specification” for preparation, submission and processing of relevant file submission under the Hong Kong Investor Identification Regime.

There are two channels to access ECP:

- ECP Web Interface via Internet; or
- ECP SFTP Interface via SDNet

## 1.2. Functions of ECP Web Interface

The following functions are available in ECP Web Interface for ECP users:

- File Download
- File Submission
- Activity Enquiry
- Self-Service SFTP Key Management<sup>1</sup>
  - Initial setup of Public Key
  - Renewal of Public Key
  - Registration of Remote IP Addresses
- Acceptance of BCAN-CID Mapping File Client Consent
- Registration for BCAN-CID Mapping File Encryption

## 1.3. Functions of ECP SFTP Interface

ECP SFTP Interface provides SFTP facility for automation of the submission and download processes. The following functions are available:

- File Download
- File Submission

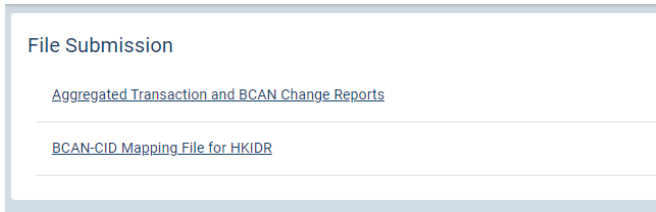

## 2. Operation of HKIDR Interface Files Exchange

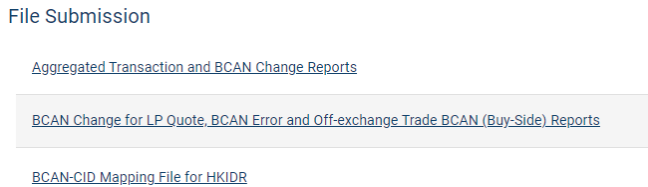
EPs/non-EP Relevant Regulated Intermediaries should observe the service hours, file submission and distribution channel of each HKIDR interface file as documented in the “Investor Identification Regime at Trading Level for the Securities Market (HKIDR) File Interface Specification”.







The following is a typical File Submission menu displays for EP.



Click “BCAN-CID Mapping File for HKIDR” for submissions of

- BCAN-CID Mapping File (File ID: HBCNMAPP)

Click “Aggregated Transaction and BCAN Change Reports” for submissions of

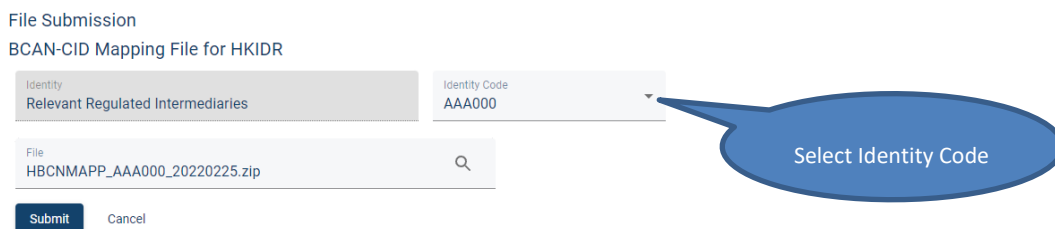
- Aggregated Transaction Report (File ID: HBCNATBN)
- BCAN Change Report (File ID: HBCNBCBN)

Click “BCAN Change for LP Quote, BCAN Error and Off-exchange Trade BCAN (Buy-Side) Reports” for submissions of

- BCAN Change for LP Quote Report (File ID: HBCNLQBN)
- BCAN Error Report (File ID: HBCNERBN)
- Off-exchange Trade BCAN (Buy-side) Report (File ID: HBCNOTBN)

After the submission type is selected, user can choose to submit for the identity the user is authorized. User can select the corresponding identity in the Identity Code field if user is authorized to submit for more than one identity.

The following screen caputre takes the submission of a BCAN-CID Mapping File as an example.



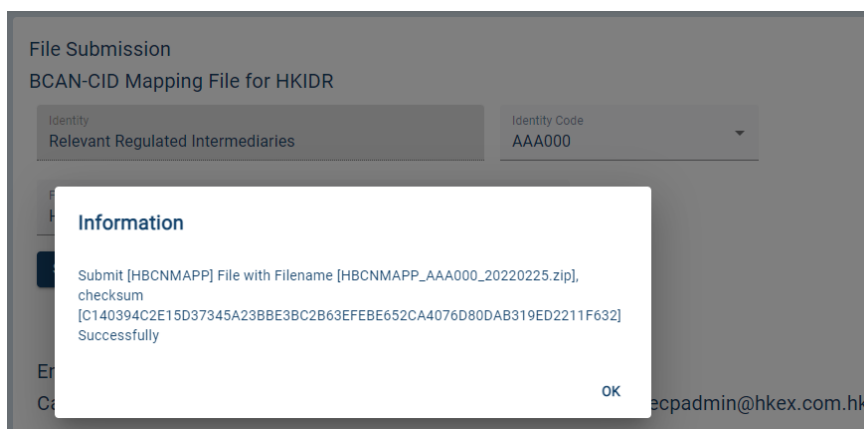
Please refer to Section 3.1 to make a one-off declaration of client consent collection prior to the first-time submission of a BCAN-CID Mapping File.

Validation on file submission:

- The file submission date must be today and must be embedded in the file name
- File name, extension and file submission time must conform to rules defined for the submission type
- Identity Code embedded in the filename must be the same as the inputted Identity Code in the page
- Must not exceed the file size limit. Please refer to Section 5.3 and Section 6.3 for the file size limit
- Must not be a zero byte file
- The compression method when must be “STOR” and “DELFTAT” creating zip file. Advanced compression method e.g. “LZMA” is not supported.

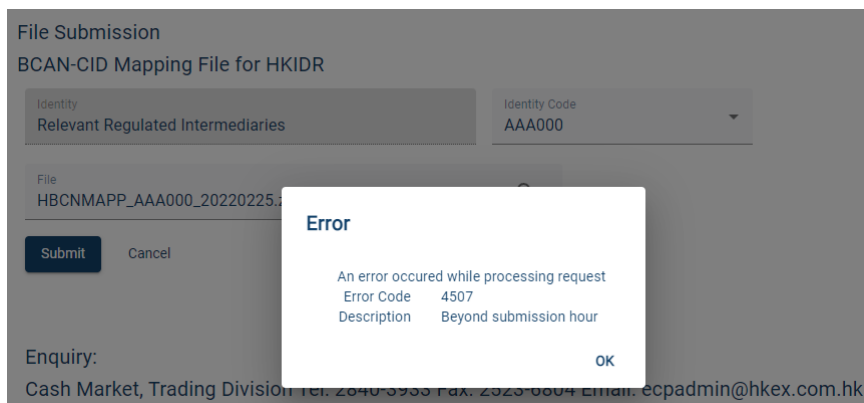
For a submission that is received by HKEX:

- A SHA-256 checksum of the file submitted will be displayed on screen upon submission.



For a submission that is rejected by HKEX:

- Rejection Code and Rejection Reason<sup>2</sup> will be displayed on screen upon submission

### 3.3. File Download

To download HKIDR interface files distributed by HKEX (e.g. BCAN-CID Response Files, response files for various reporting forms, etc.), go to the Download Corner. Download Corner is the default page upon logging into ECP. By default, the page lists all available files. User can apply filter on the list of files displayed and the date range.

BCAN-CID Response File, BCAN-CID Process Result File and BCAN Full Image File will be available for download on the same date as that for file submission. They will be distributed by HKEX and will be removed at 12:00am the next calendar day.

Response Files and Result Files of various reporting forms will be available for download within 7 calendar days after HKEX distributing the files. Files will be removed after 7 calendar days.

### 3.4. Activity Enquiry

Activity Enquiry allows the user to query user activities performed in last 30 calendar days on ECP. By default, the page lists all activities. The user can apply filter on activity types, activity status and date range.

### 3.5. SFTP Key Management

SFTP Key Management allows users to register and manage their Public Key and IP Address for accessing ECP SFTP Interface. The current SFTP Key / IP Address settings, if any, will be displayed and the user can choose to perform the following actions:

- Current Public Key Registration
- Renew Public Key Registration
- Set Remote IP Address

#### 3.5.1. Current Public Key Registration

This function allows users to register the initial public key. After the successful registration, the “Current Public Key” will be set up for accessing ECP SFTP service. The user can select the public key file to be uploaded. The expiration date will be automatically set as 2 years from the current date.

## SFTP Key Management

## Current Public Key Registration

Validations on public key file:

- File extension must be “.pub”
- Filename must not exceed 128 characters and only contains alphanumeric character plus five other characters, which are '.' (dot), '-' (dash), '\_' (underscore), ' ' (blank) and '@' (ampersand)
- The file must be in SSH2 Public Key File Format
- Key length must be between 2048 bits and 4096 bits

### 3.5.2. Renew Public Key Registration

This function is available only when there is a current public key set up. A user can upload another public key for renewal. If upload is successful, the uploaded key will be named as “Renewed Public Key”, where:

- “Renewed Public Key” expiration date = 2 years from current date
- “Current Public Key” expiration date = its original expiration date or 2 weeks from current date, whichever is earlier


After “Current Public Key” has expired, the public key will be removed and “Renewed Public Key” will become the new “Current Public Key”.

“Renewed Public Key” cannot be deleted. However, a user can upload a new one to overwrite the existing “Renewed Public Key”, and the expiration date will be renewed.

User can login SFTP facility using either “Current Public Key” or “Renewed Public Key” as long as they are not expired.

## SFTP Key Management

## Renew Public Key Registration

Validations on public key file:

- File extension must be “.pub”
- Filename must not exceed 128 characters and only contains alphanumeric character plus five other characters, which are '.' (dot), '-' (dash), '\_' (underscore), ' ' (blank) and '@' (ampersand)
- The file must be in SSH2 Public Key File Format
- Key length must be between 2048 bits and 4096 bits
- The key must be different from the existing public keys

### 3.5.3. Set Remote IP Address

The Remote IP Addresses are the IP addresses of SFTP client workstations. User can register up to a maximum of four Remote IP Addresses for SFTP access.

For a successful SFTP connection, the Remote IP Addresses must be within the same subnet (first 3 octets) of Securities and Derivatives Network/2 (SDNet/2) or HKEX Service Network (HSN) where EPs'/non-EP Relevant Regulated Intermediaries' trading system connects to OCG-C/CCCG.

Validations on Remote IP Address submission:

- All input IP addresses must be in valid IPv4 Dotted-Decimal format without leading zero, such as 10.163.3.44
- No duplicate IP Addresses found among the inputted IP Addresses
- At least one IP Address must be inputted

### 3.6. BCAN-CID Mapping File Encryption Password Register

By default without additional setup, EPs/non-EP Relevant Regulated Intermediaries can submit the zip file of BCAN-CID Mapping File without encrypting with a password.

Optionally, the zip file of BCAN-CID Mapping file can be encrypted with a password. Prior to the submission of a password-encrypted BCAN-CID Mapping File, EPs/Non-EP Relevant Regulated Intermediaries are required to register the password with HKEX at ECP Web Interface for use during decryption later.

If file encryption is enabled, BCAN-CID Mapping File must be submitted in AES 256-bit password-encrypted zip format using the same password set in here.

### Password Requirement:

- Minimum password length: 10 characters
- Maximum password length: 128 characters
- Password complexity: The password must contain a minimum of 1 uppercase letter, 1 lowercase letter, 1 number, and 1 symbol. All printable characters, except space, are accepted (i.e. ASCII code 0x21 to 0x7E). That includes upper & lower case letters, numbers (0-9), and symbols (@#\$%^&\* etc.).
- Password history: 5 generations

EPs/Non-EP Relevant Regulated Intermediaries are also advised to change the encryption password on a regular basis (e.g. every 3 months).

## 4. ECP SFTP Interface

ECP SFTP Interface is a SFTP facility that is only accessible from the Securities and Derivatives Network/2 (SDNet/2) or HKEX Service Network (HSN) which are used for connection to Orion Central Gateway – Securities Market (OCG-C)/China Connect Central Gateway (CCCG).

Please refer to Section 5.2 for the Production environment ECP SFTP Interface IP address and login information.

Please refer to Section 6.2 for the End-to-End test environment ECP SFTP Interface IP address and login information.

### 4.1. Technical Infrastructure

#### 4.1.1. SFTP Standard

The SFTP facility uses industry standard SFTP and the following protocols are supported:

#	Protocol	RFC	Remarks
1.	SFTP	RFC 4251-4254	Secure Shell File Transfer Protocol
2.	SSH Public Key File Format	RFC4716	SSH2 Public Key File Format Fingerprint: MD5 message-digest

EPs/non-EP Relevant Regulated Intermediaries are required to fully ensure that the SFTP client software<sup>3</sup> installed in their SFTP client workstations for file submission adhere to the above standard.

#### 4.1.2. Primary and Backup SFTP Facilities

In the production environment, there are two sets of SFTP facilities setup at HKEX's primary and secondary data centers respectively. Under normal condition, only SFTP facilities in the primary data center is in active mode. If a failure occurs in the primary data center, SFTP facilities in the secondary data center will be switched into active mode.

#### 4.1.3. Recommendation of SDNet bandwidth

EPs/non-EP Relevant Regulated Intermediaries can determine the bandwidth of the SDNet required for SFTP file upload/download by referring to the anticipated data volume.

For a 10 MB file, it will take approx. 1.5 minutes to upload to ECP over a 1 Mb SDNet line.

## 4.2. Secure Shell (SSH) Keys

The SFTP facility adopts Secure Shell (SSH) public-key authentication. EPs/non-EP Relevant Regulated Intermediaries need to generate a pair of SSH private and public keys and register the said public keys through ECP Web Interface for each of the SFTP user accounts.

<sup>3</sup> SFTP client software is any SFTP software run on SFTP industrial standard.



HKEX accepts RSA public keys of key length between 2048 bit and 4096 bits in SSH2 format. Each public key should be saved in a separate file with the file extension as “.pub”.

### 4.3. Folder Structure

After connecting to the SFTP facility, there are three boxes in the root level:

#	Box	Remarks
1.	download	For file distribution from HKEX to EPs/non-EP Relevant Regulated Intermediaries It contains sub-folders which the user is entitled to download Within each sub-folder, only the user entitled files are listed and available to download
2.	submission	For file submission by EPs/non-EP Relevant Regulated Intermediaries to HKEX. It contains sub-folders which the user is entitled to submit. User can upload their submission file into corresponding sub-folder
3.	key_management	User can upload their SFTP public key into <b>publickey</b> sub-folder for Public Key Renewal and download Public Key Expiry Warning File

Users are not allowed to perform any other file / directory operations other than those described above, including:

- Rename or delete any files
- Create, rename or delete any folders

For files submission, EPs/non-EP Relevant Regulated Intermediaries need to upload files to the submission box.

User accounts under the same EP/non-EP Relevant Regulated Intermediary will share the same download box. Thus users can retrieve same set of files from the download box for files that are distributed by HKEX.

For submission box and key\_management box, the files cannot be shared with other SFTP user accounts even if they belong to the same EP/non-EP Relevant Regulated Intermediary.

#### 4.4. File Submission

To submit a file, the user uploads the submission file into **/submission/<sub-folder>** using their SFTP Client.

The submitted file is processed in background and not shown in the **/submission/<sub-folder>**. After the processing has completed, an Acknowledgment File (.rcvd) or a Rejection File (.rej) is generated.

Prior to the first time submission of BCAN-CID Mapping File, EPs/non-EP Relevant Regulated Intermediaries is required to access ECP Web Interface to make a one-off declaration of client consent collection. For detail, please refer to Section 3.1 “BCAN-CID Mapping File Client Consent”.

Acceptance criteria of the submitted files:

- File name, extension and file submission time must conform to rules defined for the submission folder
- Identity Code which is CE Number / Firm ID embedded in the filename must be one of the identity codes entitled to the user
- Must not exceed the file size limit. Please refer to Section 5.3 and Section 6.3 for the file size limit
- Must not be a zero byte file
- The compression method must be “STOR” and “DEL FAT” when creating zip file. Advanced compression method e.g. “LZMA” is not supported.

Note:

- If the filename is longer than the system limit, i.e. 128 characters, the file will be rejected in SFTP level and no Rejection File will be generated.

##### 4.4.1. Submission Accepted

For a submission that is accepted, an Acknowledgment File (file extension: .rcvd) containing the submission file checksum will be generated in the submission folder if the file was submitted through SFTP.

Please refer to “A.1 Acknowledgment File” at “Investor Identification Regime at Trading Level for the Securities Market (HKIDR) File Interface Specification” for details.

#### 4.4.2. Submission Rejected

For a submission that is rejected, a Rejection File (file extension: .rej) will be generated in the submission folder if the file was submitted through SFTP.

Please refer to “A.2 Rejection File” at “Investor Identification Regime at Trading Level for the Securities Market (HKIDR) File Interface Specification” for details.

#### 4.5. File Download

User can download files published by HKEX in **/download/<sub-folder>**. Only sub-folders or files that are granted access to the user will be available for download.

#### 4.6. SFTP Key Renewal

EPs/non-EP Relevant Regulated Intermediaries are advised to renew the public keys every two years. The public key should also be renewed immediately if the private keys are compromised.

Renewal of public key can be performed either via ECP Web Interface or SFTP facility.

Public key can be renewed by uploading new public key into SFTP folder **/key\_management/publickey**. After the upload has completed, an Acknowledgment File (file extension: .rcvd) or Rejection File (file extension: .rej) is generated.

Note:

- Public Key Acknowledgement File and Rejection File are retained for a maximum of 24 hours and will be subsequently removed by system clean up
- If filename is longer than the system limit, i.e. 128 characters, the file will be rejected in SFTP level and no Rejection File will be generated
- SFTP public keys submitted through SFTP and Web Interface will be registered in the same way and the expiration date is the same

Please refer to Section 3.5.2 “Renew Public Key Registration” for the details of public key renewal processing.

##### 4.6.1. Public Key upload accepted

For a public key file upload that is accepted, a Public Key Acknowledgment File will be generated in the submission folder if the file was submitted through SFTP.

The filename is formatted as **<original file name>.<timestamp – HHMMSS>.<seq>.rcvd** in **sub-folder /key\_management/publickey** where “.<seq>” is optional and appears only when file of same name are uploaded within same second and is accepted.

For example, if 3 files with same file name are uploaded within same second and accepted, then the Public Key Acknowledgment File will be named as:

1st file: <original file name>.<timestamp – HHMMSS>.rcvd

2nd file: <original file name>.<timestamp – HHMMSS>.1.rcvd

3rd file: <original file name>.<timestamp – HHMMSS>.2.rcvd

This Public Key Acknowledgment File only contains one line, which is the uploaded public key fingerprint (MD5 hash digits of public key) in the format of 16 octets printed as hexadecimal with lowercase letters and separated by colons, for example:

12:f8:7e:78:61:b4:bf:e2:de:24:15:96:4e:d4:72:53

#### 4.6.2. Public Key upload rejected

For a public key file upload that is rejected, a Public Key Rejection File will be generated in the submission folder if the file was submitted through SFTP.

The filename is formatted as **<original file name>.<timestamp – HHMMSS>.<seq>.rej** in sub-folder **/key\_management/publickey** where “.<seq>” is optional and appears only when file of same name are uploaded within same second and is rejected.

For example, if 3 files with same file name are uploaded within same second and rejected, the Public Key Rejection File will be named as:

1st file: <original file name>.<timestamp – HHMMSS>.rej

2nd file: <original file name>.<timestamp – HHMMSS>.1.rej

3rd file: <original file name>.<timestamp – HHMMSS>.2.rej

The Public Key Rejection File is a text file in window text file format (line ends with CR+LF) in the following format:

2.	Rejection Reason	Alphanumeric	255	Rejection reason in English

The list of rejection code is the same as that described in “A.3 Rejection Codes used when submitted file is rejected” at “Investor Identification Regime at Trading Level for the Securities Market (HKIDR) File Interface Specification”.

#### 4.6.3. Public Key Expiry Warning

Public Key Expiry Warning File (“SSHKeyExpireWarning.txt”) will be shown in sub-folder **/key\_management/publickey** if the public key is going to expire within 14 days (based on the time user login).

The warning file is a fixed width text file in window text file format (line ends with CR+LF) which includes the current key and renewed key (if available). For example:

After the current public key has expired and has been removed from the system by housekeeping job, the warning file will not be shown in the folder in the next SFTP login.

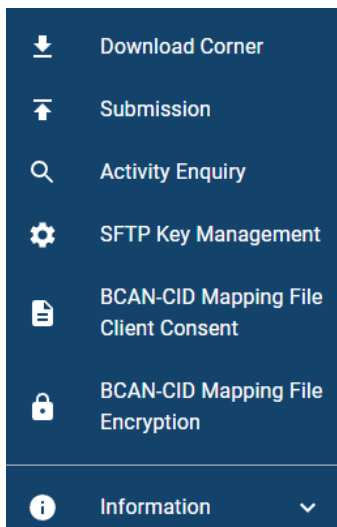

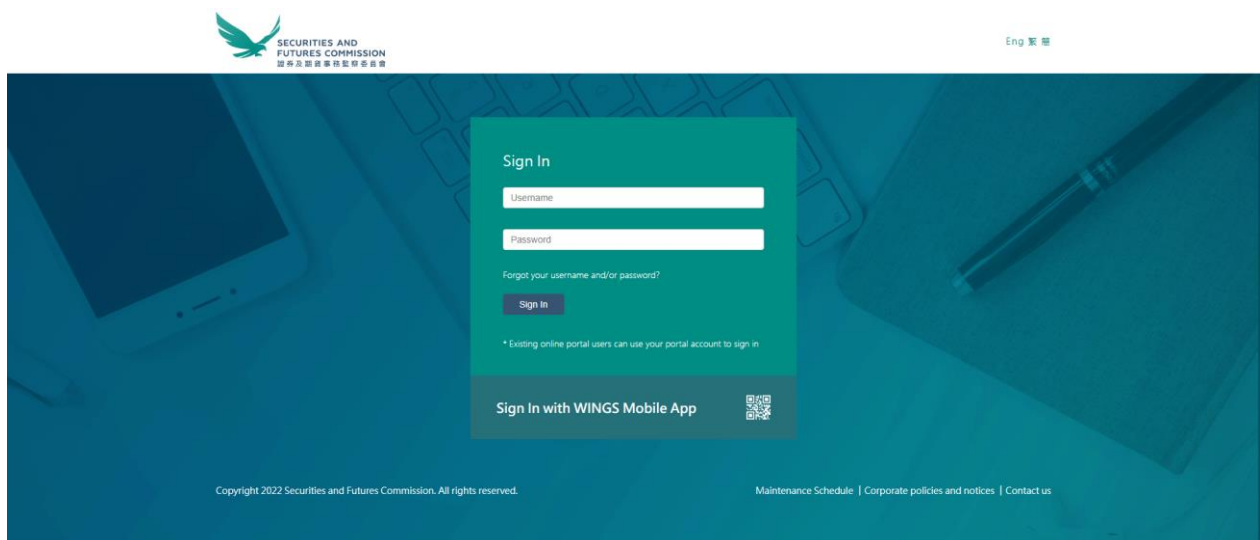

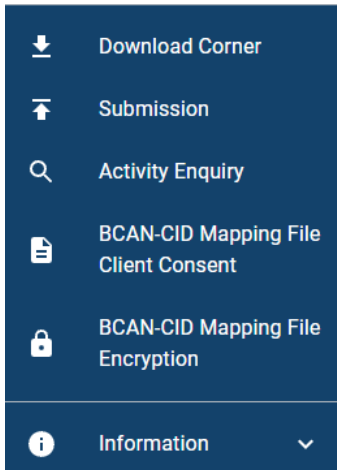
