

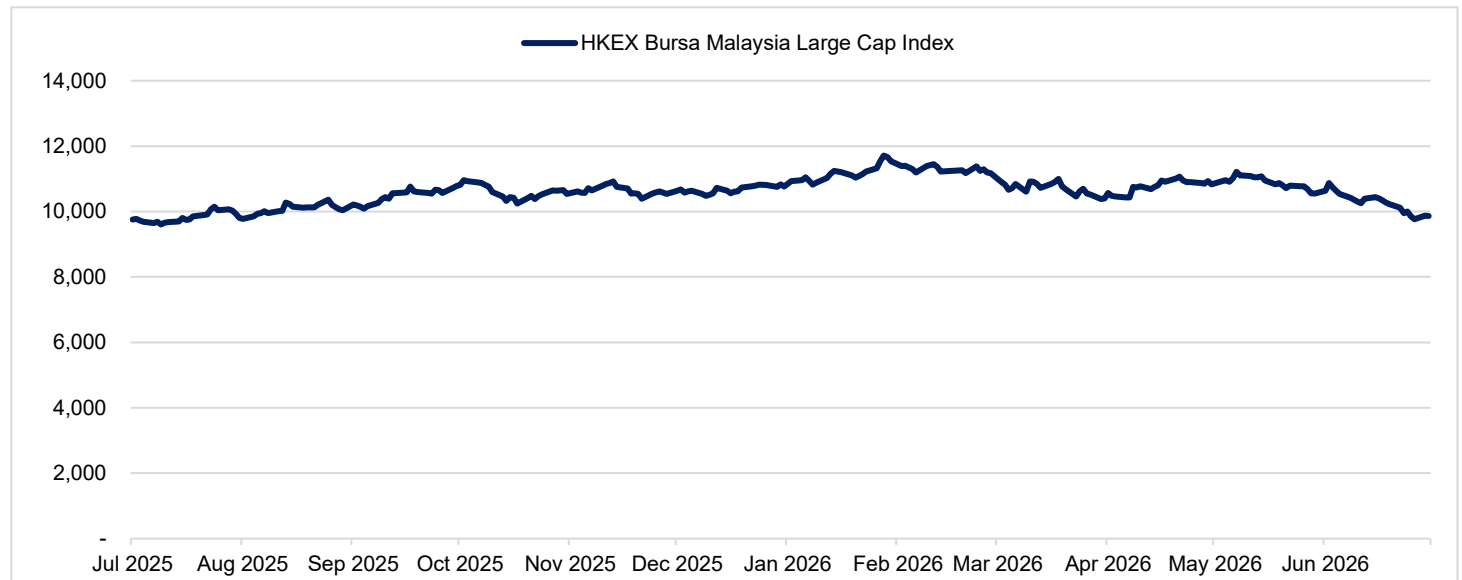
Overview

The **HKEX Bursa Malaysia Large Cap Index** (the “Index”) is designed to measure the performance of the largest companies listed in Hong Kong that are eligible for Southbound Stock Connect and the largest companies listed in Malaysia. The index is designed to offer a benchmark to support ETF product development to be eligible for Southbound ETF Connect.
