

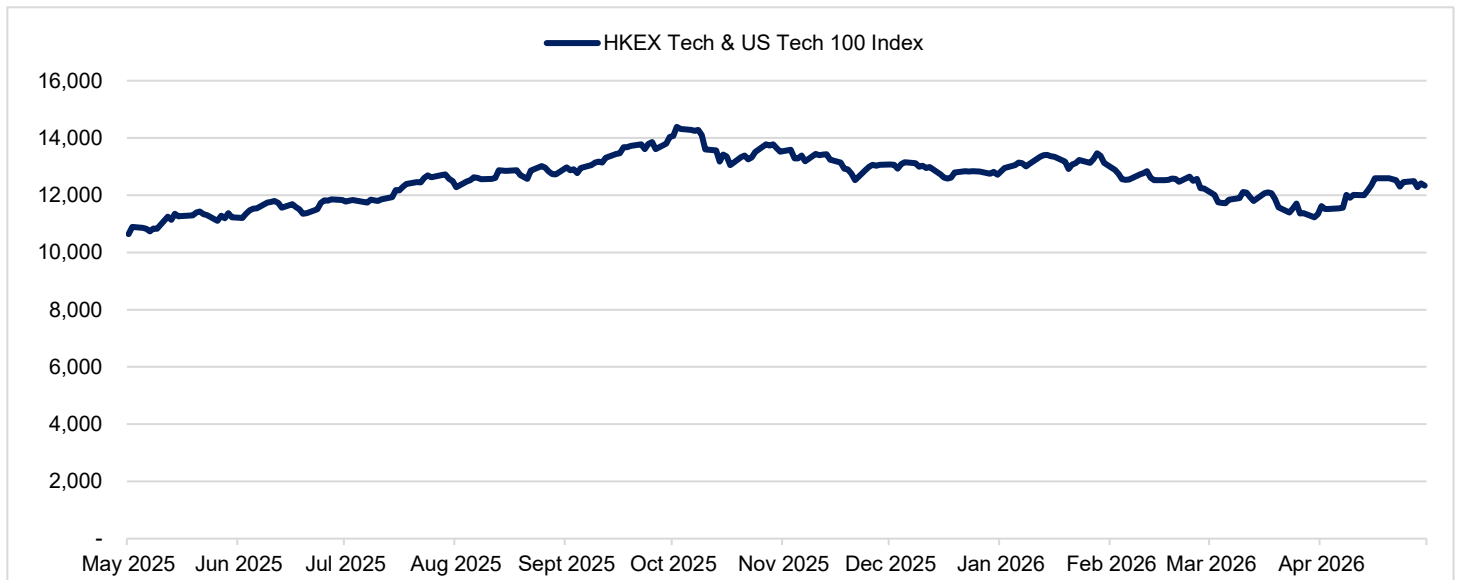
## Overview
