

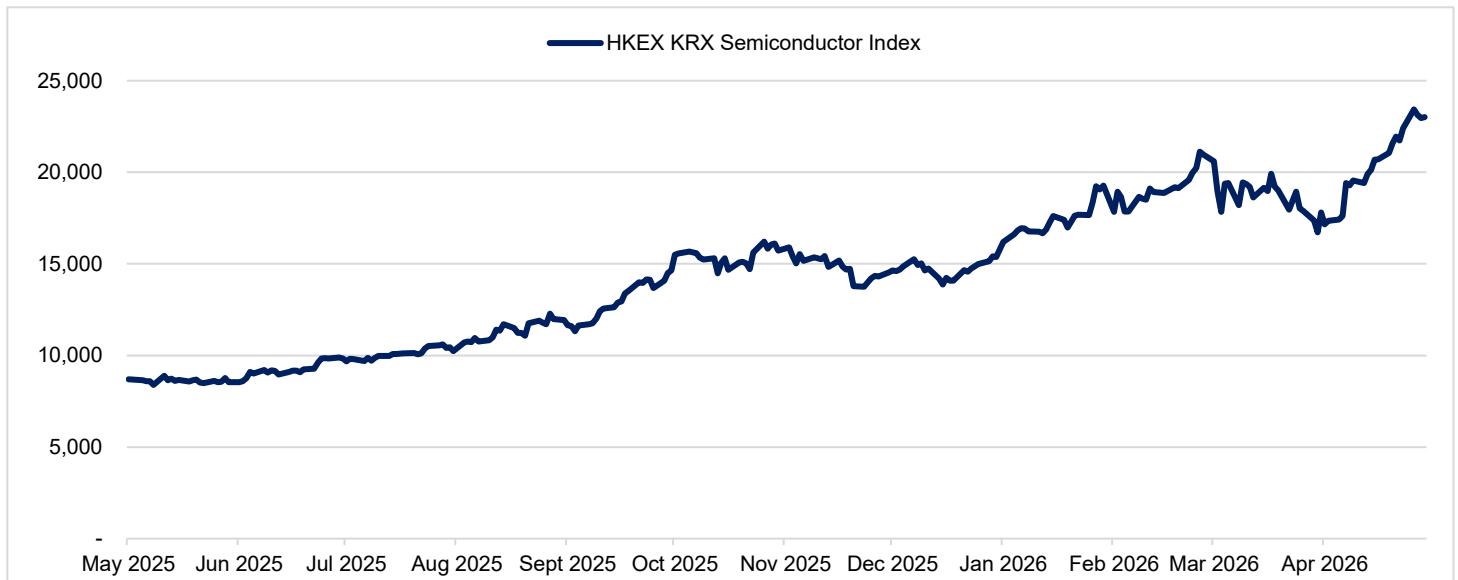
Overview

The **HKEX KRX Semiconductor Index** (the “Index”) is designed to measure the performance of semiconductor-related companies listed in Hong Kong that are eligible for Southbound Stock Connect, together with all constituents of the KRX Semiconductor Top 15 Index. The index is designed to offer a benchmark to support ETF product development to be eligible for Southbound ETF Connect.
